B.B.A LL.B. (Hons.)

B.B.A. LL.B. (Hons.) degree programme is a five-year integrated Law degree programme provided at the bachelor's level by School of Legal Studies, The Neotia University. It consists of a combined study of courses from the Bachelor of Business Administration with law education. Organizational Behaviour, Financial Accounting, Business Strategy, Business Statistics, and Human Resource Management are among the subjects covered in the Curriculum of Business Administration subjects besides Core Law courses, Clinical Law papers and Elective subjects (like Media Law, Intellectual Property Rights, Cyber Law etc.). The School of Legal Studies provide honours in 3 specializations – Business Law, International law and Intellectual Property Rights. Students have the option to choose any one of the specializations out of the three.

B.A LL.B. (Hons.)

B.A. LL.B. (Hons.) degree programme is a five-year integrated Law bachelor's degree programme offered by the School of Legal Studies, The Neotia University. It consists of a combined study of courses from the Arts stream with law education. Political Science, Sociology, and Economics are among the subjects covered in the Curriculum of Arts subjects besides Core Law courses, Clinical Law papers and Elective subjects (like Media Law, Intellectual Property Rights, Cyber Law etc.). The School of Legal Studies provide honours in 3 specializations – Business Law, International Law and Intellectual Property Rights. Students have the option to choose any one of the specializations out of the three.

Legal Aid Clinic, Awareness and Outreach Programme:

At our university, the School of Legal Studies operates a dedicated Legal Aid Clinic within the campus, offering invaluable assistance to the general public. Committed to social justice, our students, under the supervision of lawyers and faculty members, provide legal guidance and awareness, ensuring accessibility to legal services for the broader community in need. These initiatives aim to raise awareness about legal rights and access to justice. Furthermore, our students actively participated in the National Lok Adalat, providing them with valuable insights into the nuances of the legal system.
